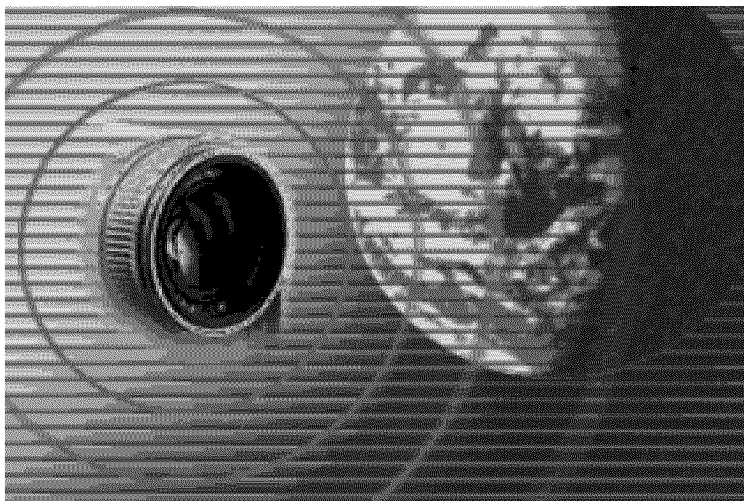

### **Precautions**

- Before using the network function, make sure you set the clock on your camcorder. For details, refer to the operating instructions of your camcorder. If you use the network function without setting the clock, you may not be able to send/receive email or view web pages.
- Do not remove the battery pack or disconnect the AC Adaptor while operating the network function, or the setup for the network function may be lost. Also, exit the network function when setting the POWER switch to OFF (CHG) or switching modes, in order to prevent the network function setup from being lost.
- It is recommended that you make backup copies of your email messages and your network preferences. These may be lost from time to time due to memory corruption. To save the network preferences, write them down on paper, or use “Setup memo,” described (p. 149). Also, this data may be lost when your camcorder is repaired by services.
- Wireless connection function using Bluetooth technology can only be used in the U.S.
- The reset button cannot reset the network preferences.

### **Note on network operation when using the battery pack**

When the remaining battery power is insufficient for network operation, use the AC Adaptor or replace the battery pack with a fully charged battery pack. Before connecting the AC Adaptor or replacing the battery pack, be sure to exit the network function.

### **Note**

Before shipment, your camcorder was configured for easy setup with “So-net” and “AOL” services. Availability and features of these services are subject to change.

**The illustrations used in this manual may be different from the actual set for some models.  
The DCR-TRV80 is the model used for illustration purposes.**

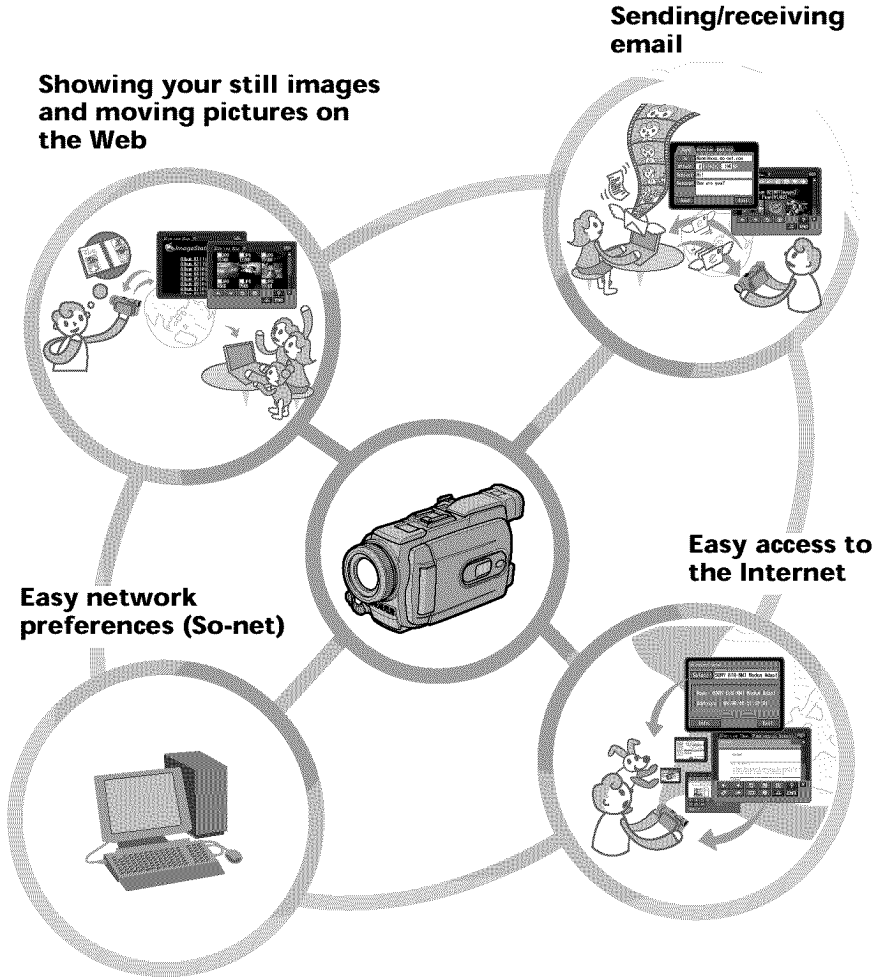

# The network function on your camcorder

Congratulations on your purchase of this Sony Handycam. Your Handycam can access the Internet via a compatible communication device, allowing you the following:



### **Showing your still images and moving pictures on the Web**

You can upload still images and moving pictures to your Album on the Web, store them on the Internet, and show them to your friends.

### **Sending/receiving email\***

You can send or receive email anytime, and attach still images and moving pictures to email messages.

### **Easy access to the Internet**

You can view web pages on the LCD screen of your camcorder.

### **Easy network preferences (So-net)**

When using a dial-up connection, you can easily set the required Internet and email preferences with the “So-net” option. For details of “So-net”, see “Using the recommended provider (So-net)” (p. 36), or refer to the supplied flyer “Getting Online with your Sony Network Handycam® camcorder”.

### **Notes**

- Set your camcorder’s clock before using the network functions. (The default setting is off.) If you do not set the clock, you cannot send/receive email or view web pages.
- You have to set up your camcorder and any peripheral devices, and finish the required registrations (DI customer registration, etc.).  
For details, refer to the supplied flyer “Getting Online with your Sony Network Handycam® camcorder”.  
 (“DI” in “DI customer ID” stands for “Digital Imaging”.)

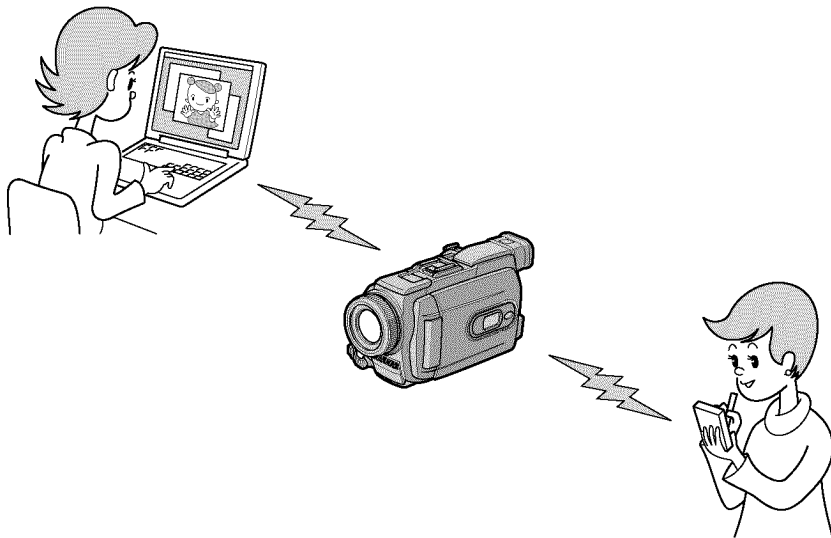
\* As of March 2003, “AOL” does not support the receiving of email on this device. For further clarification on this and other “AOL”-specific attributes, go to keyword: Handycam on your computer.

# The Bluetooth function on your camcorder

---

## - DCR-TRV80 only

Your camcorder is designed to communicate with another Bluetooth device, such as a computer, or a PDA. Without connecting a cable, you can transfer still image, and can use your camcorder as a remote camera and shoot remotely from a computer or a PDA.



## Using as a Remote Camera

You can operate your camcorder remotely from a BIP\* compatible computer or PDA with Bluetooth function.

## Transferring still images - Image Transport

You can transfer still images between your camcorder and a BIP\* compatible computer or PDA with Bluetooth function.

\* About BIP (Basic Imaging Profile)

The "Basic Imaging Profile" (BIP) is the Bluetooth specification used when transferring images between Bluetooth devices. To connect with your camcorder, the Bluetooth device must be compatible with the "Image Push Feature" or the "Remote Camera Feature" of the "Basic Imaging Profile" (BIP). Before using the Bluetooth device, check the BIP specifications of the device.

# On network operation

This section describes the basic ways to operate your camcorder's network function. For details of how to hold your camcorder when operating the network function, refer to the operating instructions supplied with your camcorder.

## Note

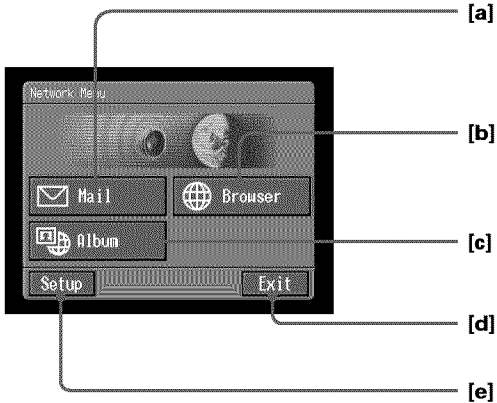
Before using the network function, be sure to set the clock on your camcorder. For details of clock setting, refer to "Setting the date and time" in the operating instructions of your camcorder.

## How to use the Network Menu

Tap the desired network function on the Network Menu.

To display the Network Menu, set the POWER switch to MEMORY/NETWORK and tap NETWORK.

For details, refer to "Accessing the network" in the operating instructions supplied with your camcorder.



**[a]:** For sending and/or receiving email, tap this button (p. 82).

**[b]:** For viewing a web page through the Internet, tap this button (p. 106).

**[c]:** For uploading still images and moving pictures to your Album on the Web and storing them on the Internet, and for showing them to your friends, tap this button (p. 68).

**[d]:** For exiting the Network Menu, tap this button.

**[e]:** For changing the settings, tap this button.

The actual screens may differ from the illustrations in Network Function/ Application Operating Instructions.

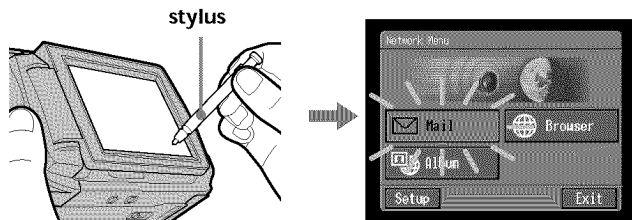
## On network operation

### How to use the stylus

The buttons required for operating your camcorder appear on the LCD screen. Operate by pressing the buttons on the screen directly but lightly with the stylus supplied. In this manual, pressing the buttons in this way using the stylus is referred to as "tapping".

#### Tap the desired button on the screen with the stylus.

The selected button turns orange.



#### Notes

- Use the stylus supplied to tap the LCD screen.
- Do not tap the LCD screen too hard.
- Do not touch the LCD screen with wet hands.
- When the LCD screen gets dirty, clean it with the supplied cleaning cloth.
- You cannot drag icons, as on a computer, by touching and sliding across your camcorder screen with the stylus.



- Refer to the operating instructions supplied with your camcorder for the stylus holder location. To avoid losing the stylus, we recommend that you always return it to the holder after use.

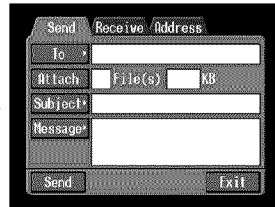
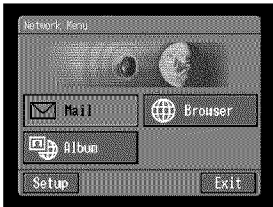
## How to input characters

You have to frequently enter characters, such as email addresses or web pages addresses (URLs), to use the network function. This section describes how to input characters.

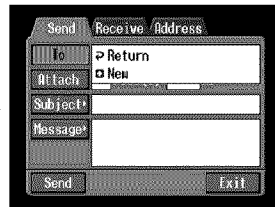
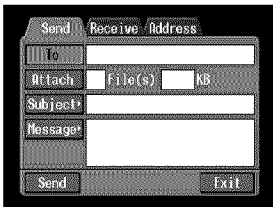
- 1** Open the Network Menu.

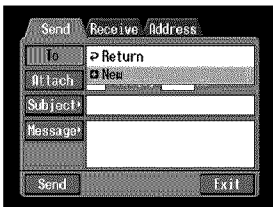
- 2** Tap [✉ Mail].  
The Send screen appears.



- 3** Tap [To].



- 4** Tap [+ New].  
The character input screen appears.

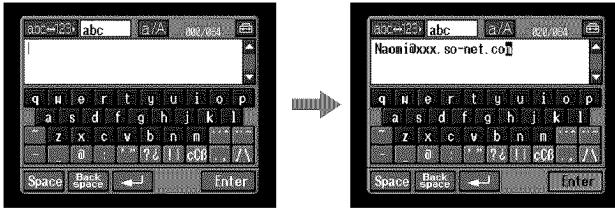

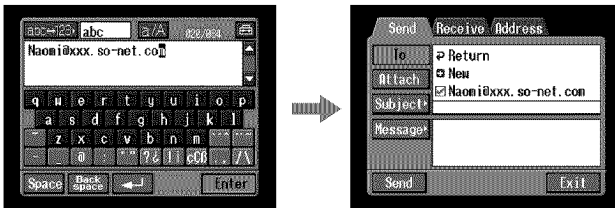


## 3 Inputting characters

(1) Tap the characters you want to input.

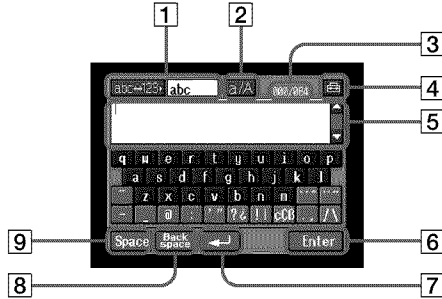


(2) After you input the characters, tap [Enter].  
The Send screen appears again.



# Inputting characters

## The character input screen



- 1 [abc↔123] button**  
A list box appears when you tap the [abc↔123] button. Tap the desired type of character (alphabets or numbers) from the list box.
- 2 [a/A] button**  
The [a/A] button appears when you input alphabets. You can switch between upper case and lower case.
- 3 Input byte number/maximum byte number**
- 4 Preferences**  
You can change the keyboard arrangement for alphabets.
- 5 Text area**  
If the text is long, you can scroll up or down by tapping ▲ or ▼ (scroll buttons) to display the hidden text.
- 6 [Enter] button**  
Tap this button to decide or close the character input screen.
- 7 [↵] button**  
Tap this button once to move the cursor to the next line.
- 8 [Back space] button**  
Tap this button, and the letter just before the cursor is deleted. If you tap the button for about three seconds, all the characters before the cursor are deleted.
- 9 [Space] button**  
Tap this button to insert a space.

### To switch between upper and lower case alphabet letters

Tap [a/A] to change the alphabetical keyboard, then enter characters.

### To delete a character

Move the cursor with the stylus just to the right of the character that you want to delete, and tap [Back space]. The character to the left of the cursor is deleted.

### To add a character

Move the cursor with the stylus to the position at which you want to add a character, then input the character.

### To begin a new line

Tap [↵].

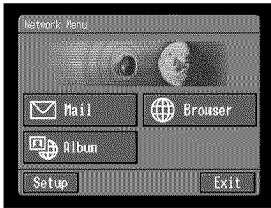

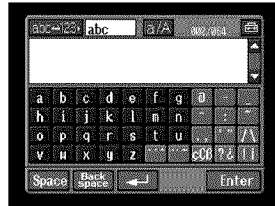

# Using the network functions

There are three network functions, namely Album on the Web, email, and browser. To use the Album on the Web and "So-net" option, you need to finish customer registration.

"So-net" is charged service. For details, refer to the supplied flyer "Getting Online with your Sony Network Handycam® camcorder".

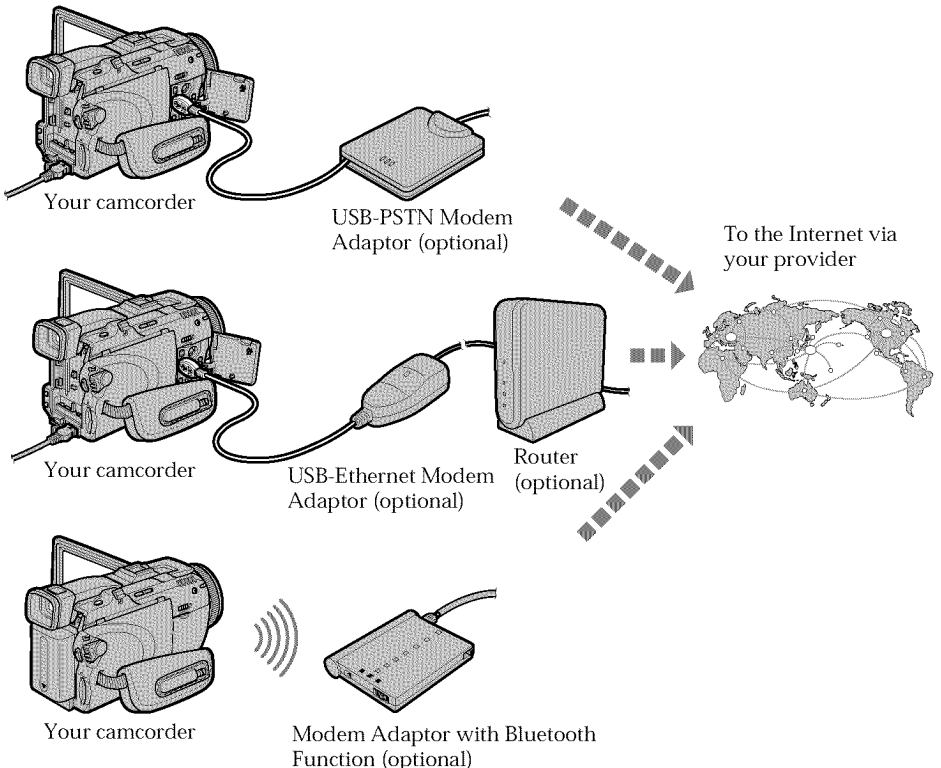
To fully enjoy the network functions, you have to finish the following registrations and setup tasks:

- 1 USB device Setup (p. 19) or Bluetooth device registration\* (p. 24)**
- 2 DI customer registration (p. 32)**
- 3 Album registration (p. 35)**
- 4 So-net registration\*\* (p. 37)**
- 5 Network Setup (p. 38)**

\* You can carry out Bluetooth device registration with the DCR-TRV80 only.

\*\* So-net registration is not necessary if you use other providers.

# Setting up USB devices

Here we describe how to connect to the Internet with the USB devices.

There are two optional USB devices that can connect to your camcorder below:

- USB-PSTN Modem Adaptor (supplied to DCR-TRV39) (p. 20)
- USB-Ethernet Adaptor (p. 22)

For details of using these USB devices connected to your camcorder, refer also to the operating instructions of the USB devices.

## What is USB?

USB stands for Universal Serial Bus. It is the specification for connecting various data communication devices such as computers and their peripherals, PDAs and mobile phones.

## Before connection

### Priority sequence of communication devices

#### - DCR-TRV80 only

When connected to a USB device but also within range of a Bluetooth device, your camcorder automatically gives priority to communication with the USB device.

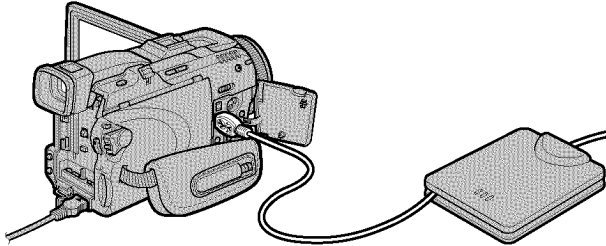
#### Notes

- Do not connect your camcorder with a USB device that is not a communication device. Otherwise, "The Connected USB Device is not Compatible" appears on the screen and your camcorder cannot communicate.
- Connect a USB device to your camcorder directly. Your camcorder cannot access the Internet when connected through a USB hub.
- When using a Bluetooth device as a communication device, do not connect a USB device to your camcorder (DCR-TRV80 only).

## Setting up USB devices

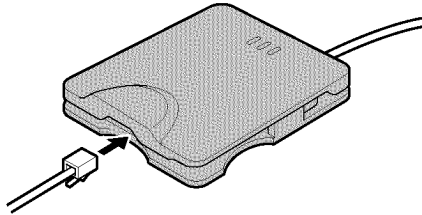
### Connecting to a telephone line via the USB-PSTN Modem Adaptor

Connect your camcorder to a telephone line via a USB Modem Adaptor to access the Internet.

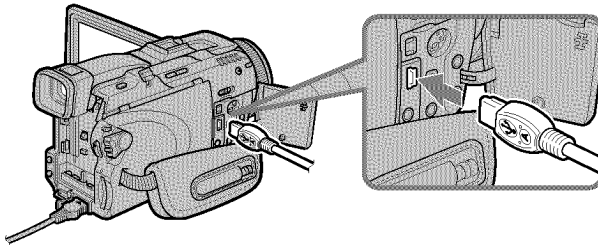


The following procedure shows you how to connect to a telephone line via the Sony USB-PSTN Modem Adaptor.

- (1) Connect the USB-PSTN Modem Adaptor to the telephone line.



- (2) Open the jack cover of your camcorder.
- (3) Connect  $\Psi$  (USB) jack of your camcorder and the USB connector of the USB-PSTN Modem Adaptor.



#### Tip

The  $\Psi$  (USB) jack location is different depending on the model. For details, refer to the operating instructions supplied with your camcorder.

## Setting up USB devices

---

- (4) Open the Network Menu.

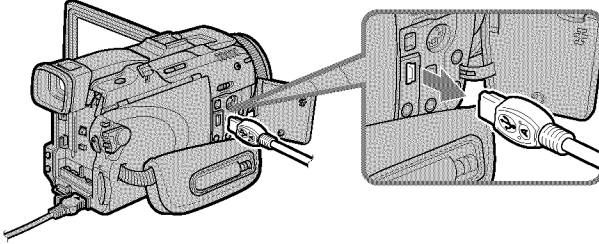

### Note

Connect the USB-PSTN Modem Adaptor with your camcorder directly. Your camcorder cannot access the Internet when connected through a USB hub.

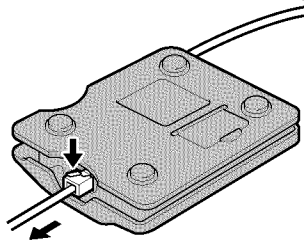
### To disconnect your camcorder from the telephone line

- (1) Remove the USB connector of the USB-PSTN Modem Adaptor from  $\Psi$  (USB) jack of your camcorder.



- (2) Close the jack cover of your camcorder.

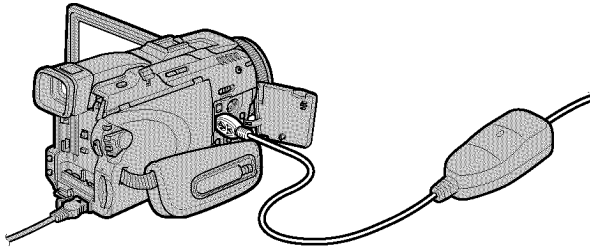
- (3) Remove the telephone line from the USB-PSTN Modem Adaptor.



## Setting up USB devices

### Connecting to LAN with the USB-Ethernet Adaptor

Connect your camcorder to the Internet via a LAN (Ethernet) adaptor.

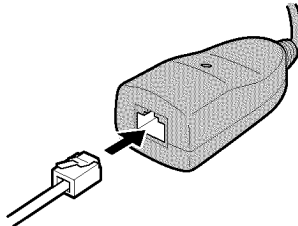


The following procedure shows you how to connect to LAN via the Sony USB-Ethernet Adaptor.

#### Notes

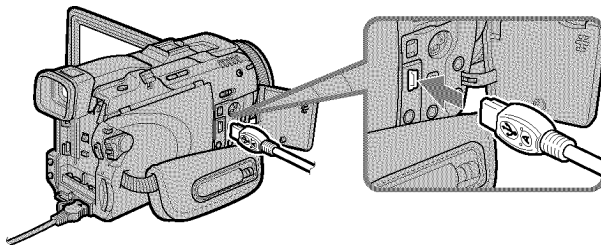
- You may not be able to use the email function, depending on your provider.
- If you use your camcorder in a company, for example, ask the network manager about the proxy settings for the mail server and browser.

(1) Connect the USB-Ethernet Adaptor to a LAN cable.



(2) Open the jack cover of your camcorder.

(3) Connect  $\Psi$  (USB) jack of your camcorder and the USB connector of the USB-Ethernet Adaptor.



#### Tip

The  $\Psi$  (USB) jack location is different depending on the model.  
For details, refer to the operating instructions supplied with your camcorder.

## Setting up USB devices

- (4) Open the Network Menu.

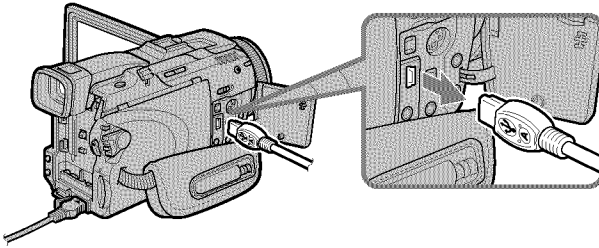
For details of how to open the Network Menu, see page 7.

### Notes

- Directly connect the USB-Ethernet Adaptor with your camcorder. Your camcorder cannot access the Internet when connected through a USB hub.
- Do not connect an unspecified network or telephone line to the USB-Ethernet Adaptor. Doing so may cause a malfunction, overheating or fire. For details, refer to the operating instructions supplied with the USB-Ethernet Adaptor.

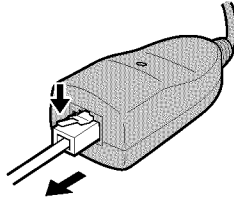
### To disconnect your camcorder from LAN

- (1) Remove the USB connector of the USB Ethernet Adaptor from  $\Psi$  (USB) jack of your camcorder.



- (2) Close the jack cover of your camcorder.

- (3) Remove the LAN cable from the USB Ethernet Adaptor.



# Registering Bluetooth devices

---

- DCR-TRV80 only

## Before communication

### What is Bluetooth wireless technology?

Bluetooth wireless technology allows communication between various Bluetooth devices without using cables. Devices which can use this technology include PCs, computer peripheral devices, PDAs, and mobile phones. This omnidirectional communication system enables connection even if a Bluetooth device is in a bag, for example, or there is an obstacle between devices.

Also, the Bluetooth wireless technology has advanced security functions, such as scrambled frequencies and data encryption.


### Authentication

The authentication routine can block unspecified users' access to this network. When attempting communication with an unregistered Bluetooth device, the devices must first be registered with each other by entering a common passkey to each device. When connecting with a previously registered Bluetooth device, communication starts without you entering the passkey.

### Tip on "Passkey"

The passkey is a 1 to 16 character identification number needed to allow two Bluetooth devices to communicate with each other. The connection will be permitted after entering the passkey. This "Passkey" is sometimes referred to as the "Bluetooth passkey", "PIN", "Bluetooth PIN", etc.

### Radio wave indication

 indicates the radio wave status of the connected Bluetooth device. (Use this indication as a guide.)



# Registering Bluetooth devices

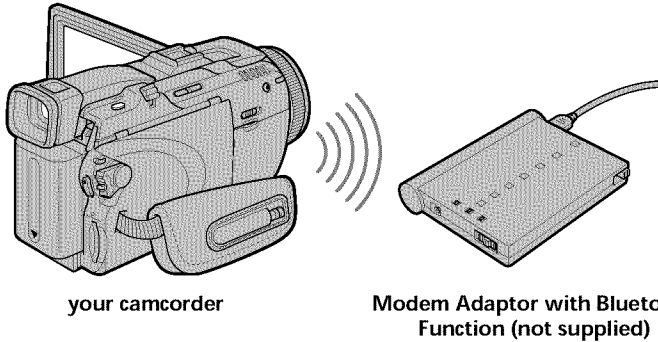
## Registering a Bluetooth device

To enable your camcorder to communicate with a Bluetooth device, the devices should be registered with each other. Here we describe how to register the Sony Modem Adaptor with Bluetooth Function. Once registration is complete, you do not have to reregister the Bluetooth device as long as you do not cancel registration. You can register up to three Bluetooth devices to your camcorder. Refer also to the operating instructions supplied with each Bluetooth device.

## Using the Modem Adaptor with Bluetooth Function

Connect your camcorder to a Bluetooth device by Bluetooth wireless technology.



### Notes

- When using Sony BTA-NW1/BTA-NW1A Modem Adaptor with Bluetooth Function, place it so that there are no obstacles between your camcorder and the device. The distance between the devices must be within 10 m (33 feet).
- The connection may be interrupted depending on the communication conditions.
- When your camcorder is connected to a USB device, your camcorder cannot communicate via a Bluetooth device.
- Do not remove the battery pack while your camcorder is communicating with Bluetooth devices. Doing so may cause malfunction of your camcorder.

## 1 Preparing a Modem Adaptor with Bluetooth Function

Set a Modem Adaptor with Bluetooth Function to connection standby (BONDING). For details, refer to the operating instructions supplied with the Modem Adaptor.

## Registering Bluetooth devices

### 2 Specifying your Modem Adaptor with Bluetooth Function as the connection device

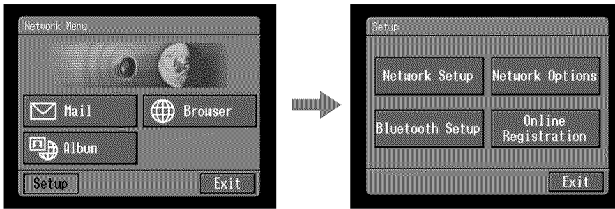
- (1) Open the Network Menu.

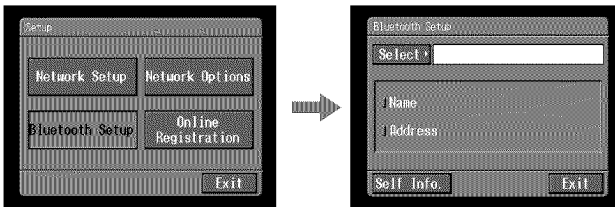
- (2) Tap [Setup].

The Setup screen appears.



- (3) Tap [Bluetooth Setup].

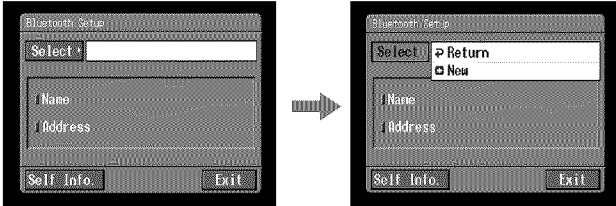
The Bluetooth Setup screen appears.



## Registering Bluetooth devices

**(4)** Tap [Select].

The registered Bluetooth device list appears. When registering for the first time, only [Return] and [New] appear. The list shows up to three most recently used Bluetooth devices. You can select one of the three Bluetooth devices from the list.



**Tip**

The most recently used Bluetooth device is listed next to [Return] and [New].

**(5)** Tap [New].

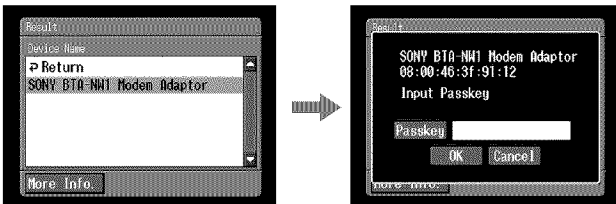
Your camcorder starts searching for Bluetooth devices. When the search is complete, the available Bluetooth devices are listed. If more than one Bluetooth devices with the same name appear, display each Bluetooth device address by tapping [More Info].



**Notes**

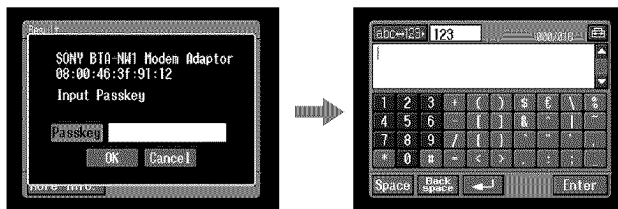
- The search takes about 10 to 60 seconds. The time depends on the number of Bluetooth devices around your camcorder.
- If the Bluetooth device you want to register is not found, follow the procedure again from step 4.

**(6)** Tap the desired Bluetooth device.  
The passkey input screen appears.

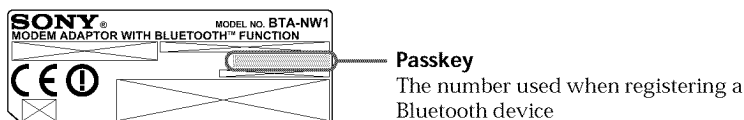


## Registering Bluetooth devices

- (7) Tap [Passkey].  
The character input screen appears.



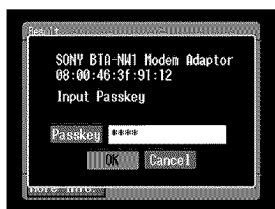
- (8) Enter the passkey.  
For details of how to input characters, see “How to input characters” (p. 9).  
For example, when using the BTA-NW1/BTA-NW1A Modem Adaptor, the passkey is the same as its serial number indicated on the label on the rear panel.



### Tip on “Passkey”

The passkey is an identification number needed to allow two Bluetooth devices to communicate with each other. The connection is permitted after you enter the passkey. This “Passkey” is sometimes referred to as the “Bluetooth passkey”, “PIN”, “Bluetooth PIN”, etc. For details, refer also to the operating instructions supplied with the modem adaptor.

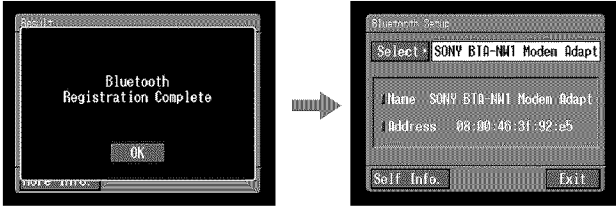
- (9) Tap [Enter].  
When registration is complete, the Bluetooth Setup screen appears again and the message “Bluetooth Registration Complete” appears.
- (10) Tap [OK].



# Registering Bluetooth devices

(11) Tap [OK].

The selected Bluetooth device is specified.

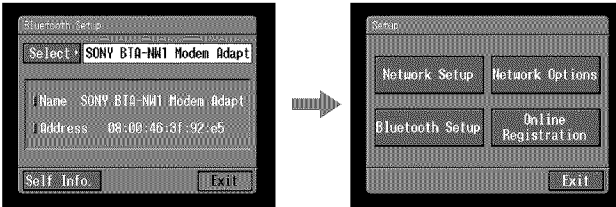


### Note

If the message "Bluetooth Registration Error Check the Passkey" appears, tap [OK], then follow the procedure again from step 4.

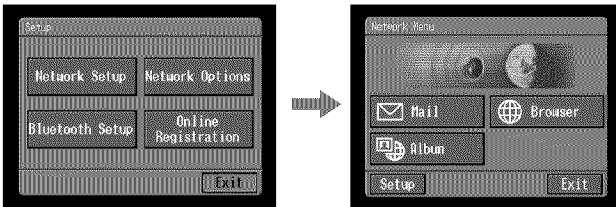
(12) Tap [Exit].

The Setup screen appears again. For details of how to turn off the Modem Adaptor with Bluetooth Function, refer to the operating instructions supplied with the Modem Adaptor.



(13) Tap [Exit].

The Network Menu appears again.



Registration is complete and your camcorder can communicate with the selected Bluetooth device.

## Registering Bluetooth devices

### Changing the communication devices

#### Changing from a USB device to a Bluetooth device

Unplug the USB device from the  $\Psi$  (USB) jack of your camcorder. When a Bluetooth device is registered, your camcorder automatically selects the Bluetooth device as a communication device.

You can carry out DI customer registration in one of the following ways:

① Online registration with a computer (recommended)

② Online registration with your camcorder

When you finish your DI customer registration, your DI customer ID and password are issued immediately.

### Tip

After DI customer registration, you can continue to register your Album on the Web and “So-net”.

## Online registration with a computer

You can carry out customer registration with a computer. The URL of the web site for online registration is “<http://www.myimagecam.com/>”.

### Tip

We recommend online registration with a computer if you have a computer and you do not want to input many characters on your camcorder.

## Online registration with your camcorder

You can carry out DI customer registration with your camcorder.

For online registration with your camcorder, you must use a private line. Since the registration process is assigned a toll-free telephone number, the telephone charge for online registration will not be added to your telephone bill if you use a dial-up connection.

### Notes

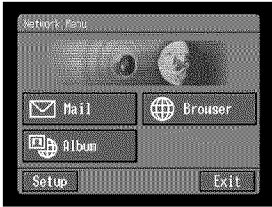
- Set up your camcorder and a communication device so that they are communicating with each other beforehand. For details, refer to the operating instructions of the communication device.
- It may take a while to finish online registration.
- Use the AC Adaptor when registering online with your camcorder.
- Be sure to set the clock of your camcorder beforehand. For details, refer to “Setting the date and time” in the operating instructions supplied with your camcorder.
- If you use a LAN connection, you may need to perform certain settings before carrying out online registration with your camcorder.
- You cannot carry out online registration with your camcorder in a LAN environment that has a firewall, such as in a company.

# Setting the Internet connection

## Internet service provider

To access the Internet, you have to sign up with an Internet service provider (ISP). The provider acts as an intermediary between your camcorder and the Internet. After you sign up with a provider, you can view various web pages through the Internet, and you can send/receive email with your email address. The email address is a destination address in an email transmission. Various other services may be available depending on your provider.

### Notes

- A credit card number may be required to sign up with some providers.
- The connection fee differs depending on providers.

### Using the recommended provider (So-net)

“So-net” is an Internet service provider. For details of “So-net” services, refer to the supplied flyer “Getting Online with your Sony Network Handycam® camcorder”.

The “So-net” option makes it easy to set the Internet and email preferences. Once you complete DI customer registration, your DI customer ID and password are issued. Enter your DI customer ID, password, and the telephone number of an access point, and you can access the Internet right away.

For details of setup, see “Setting your provider preferences for “So-net”” (p. 38).

### Using America Online (AOL)

“AOL” is an Internet service provider. Before setting your provider preferences with “AOL”, go to keyword: Handycam on your computer.

You cannot access the Internet via “AOL” when your camcorder is connected with a USB-Ethernet Adaptor.

For details of setup, see “Setting your provider preferences for “AOL”” (p. 48).

### Using other providers

When using another provider or when not using the “So-net” or “AOL” option, you have to set the Internet and email preferences. For details of setup, see “Setting your provider preferences for other providers” (p. 54).

You cannot use the network function when using a provider other than AOL that requires its own exclusive browser software.

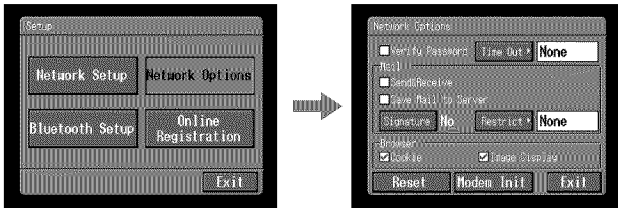
## Setting other preferences

You can access the Internet with your camcorder using the default settings explained on previous pages. It is not necessary to make the following settings, however, see the following when any changes are necessary in the future.

- (1) Open the Network Menu and tap [Setup].  
The Setup screen appears.



- (2) Tap [Network Options].  
The Network Options screen appears.



- (3) Set the following items:

**Verify Password:** Check this item to delete your DI Customer Setup password, “AOL” password, and PPP screen password. You will have to enter your provider access password each time you access the Internet, for example, when you use a dial-up connection to prevent anyone else from connecting with your ID.

### Note

If this item is checked, you cannot set the following passwords:

- Password for DI Customer Setup (when using “So-net”)
- Password for AOL Network Setup (when using “AOL”)
- Password for the PPP screen (when using other providers)

**Time Out:** Select whether the connection is to be automatically canceled if no communication is made for a specified time (1 minute, 2 minutes, 5 minutes, 15 minutes, or 30 minutes) (When you use a LAN connection, the connection is not disconnected automatically.).

### Note

When you use a dial-up connection, the telephone line may not be disconnected automatically when viewing certain web pages. In this case, disconnect the telephone line manually (p. 81, 119).

## Setting the network preferences

---

### Mail

**Send&Receive:** Select whether to check the email inbox after sending email.

**Save Mail to Server:** Select whether to keep copies of the messages on the server.

### Note

If you try to receive email without checking this item, email messages may not be downloaded and **may be lost from your server**, depending on the type of the received email. For details, see “Note on “Save Mail to Server”” (p. 67).

**Signature:** Set this item if you want to attach your signature to your email (p. 92).

**Restrict:** Select whether to skip an email message if its file size is larger than 50 KB, 200KB, or 500KB.

### Browser

**Cookie:** Select whether to accept a cookie. If you do not want to send your personal information, do not check this item. This item is checked by the default setting.

**Image Display:** Select whether to display images on the screen when viewing a web page. This item is checked by the default setting.

**Reset:** Reset all the items on the Network Options screen except “Signature” and “Modem Init”.

### Note

A verification message does not appear when you try to reset items.

**Modem Init:** Set the character string to be used for modem initialization. If no setup is specified, you do not need to modify this item.

### Note

If the setup is wrong, you cannot access the Internet. When you try to access the Internet, the message “Connection Error No Response From PPP server” appears.

- (4) Tap [Exit].  
The Setup screen appears again.

## Setting the network preferences

### Note on "Save Mail to Server"

When "Save Mail to Server" is not checked, copies of email messages received will not be stored on your server. However, the error messages described in the table below will appear, depending on the type of email messages.

Error message <sup>1)</sup>	Cause and/or Corrective Actions
Memory Stick Memory Full	<p>You received email when the "Memory Stick" was already full. <sup>2)</sup></p> <ul style="list-style-type: none"><li>→ Delete the email containing this error message, and delete unnecessary email messages or image files in the "Memory Stick," then download your email again.</li><li>→ Insert another "Memory Stick" that has enough memory, then download your email again.</li></ul>
Mail Over Size Limit	<ul style="list-style-type: none"><li>• You received email larger than the size set in the item "Restrict". <sup>2)</sup><ul style="list-style-type: none"><li>→ You can download the email with a computer, etc.</li><li>→ Delete the email, uncheck the item "Restrict", and download the email again.</li></ul></li><li>• You received email with a message of 4,000 characters or more. <sup>3)</sup><ul style="list-style-type: none"><li>→ Your camcorder cannot receive an email message that has 4,000 characters or more. <sup>4)</sup></li></ul></li></ul>
Attached Invalid File Deleted	<p>You received email that has an attached file with an invalid file name extension. <sup>3)</sup></p> <ul style="list-style-type: none"><li>→ Your camcorder can receive only JPEG or MPEG files.</li></ul>
Folder No. Full	<ul style="list-style-type: none"><li>→ Insert another "Memory Stick" that has enough memory, then download your email again.</li></ul>

<sup>1)</sup> These error messages are indicated in an email message.

<sup>2)</sup> This email message is stored on the server even if you did not check the item "Save Mail to Server". You can retrieve it with a computer, etc.

<sup>3)</sup> The previously downloaded email is not stored on the server if you did not check the item "Save Mail to Server". You cannot retrieve it with a computer, etc.

<sup>4)</sup> For an email message that has a lot of line breaks, the number of available characters is less than 4,000.

The Album on the Web is provided with “ImageStation”.

You can make an Album on the Web and send email with its URL as an invitation card to your friends.

You can also access your Album on the Web with a computer. To do so, log in to the “ImageStation” web site with your DI customer ID and password.

## Uploading still images and/or moving pictures to your Album on the Web

Once you have an Album on the Web, you can upload still images and/or moving pictures to the album, and send invitation cards (email) to your friends. This section describes how to upload your still images and/or moving pictures and send invitation cards (email).

Upload moving pictures within the file size constraints of “ImageStation”. For details, access the “ImageStation” web site “<http://www.imagestation.com/us/PC/>”.

### Before operation

Store the desired still images and/or moving pictures on a “Memory Stick” and insert it into your camcorder.

# Using email

This section describes the basic procedure for sending/receiving email via the Internet. Email is very convenient, since you can send it anytime, and you can also send still images and/or moving pictures stored in a “Memory Stick” by attaching them to email.

As of March 2003, “AOL” does not support the receiving of email on this device. For further clarification on this and other “AOL”-specific attributes, go to keyword: Handycam on your computer.

## Sending email

By entering the destination email address, you can send an email message instantly.

### 1 Specifying a destination address

Be careful to enter the address correctly.

#### Tip

You can select an email address from the address book. For details, see “Selecting a destination address from the address book” (p. 98).

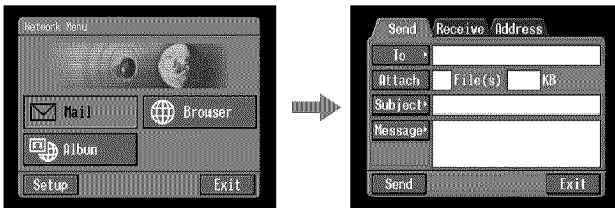

Sending email may take a while, depending on the size of the still image or moving picture.

The screen for verifying the connection appears.



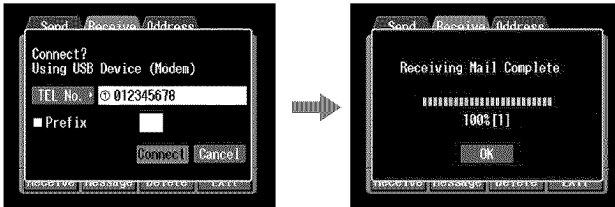
If you use a dial-up connection, dial the telephone number displayed on the screen for verifying the connection. If you want to dial other telephone numbers, tap [TEL No.] to display the list of registered telephone numbers. Tap the desired telephone number to select it.

To connect to an outside line, for example in a hotel, check the item "Prefix No." and enter the prefix number.

When you use a LAN connection, the screen for verifying the connection may not appear.

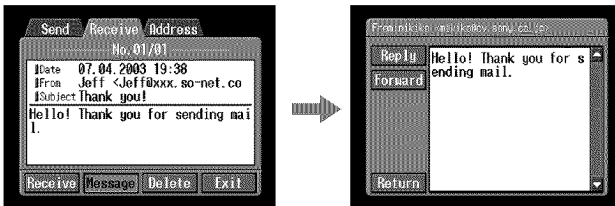
**(5)** Tap [Connect].

If you use a dial-up connection, your camcorder starts dialing the selected telephone number. If an email message has been sent to you, your camcorder downloads it, and the message "Receiving Mail Complete" appears. If you use a dial-up connection, tap [OK]. The telephone line is automatically disconnected after email is received.




**(6)** If an email message has been received, tap the area where the message is displayed or [Message].

The message appears.



When two or more email messages are received, the number of email appears above the message. (For example, No. 1/3 is the first of three email messages.)

To read the next email message, tap .

- (7) Tap [Return].  
The Receive screen appears again.

### To cancel receiving email

Tap [Cancel] while downloading. Email you did not download remains on the mail server.

### If the message is long

Tap the scroll button ▼ to scroll the message.

### If a file is attached to the email message

Your camcorder can receive files with the following extensions: **.jpg**, **.mpg**, **.jpeg** and **.mpeg**. If you receive files other than these files, the message "Attached Invalid File Deleted" is inserted in the email message. Your camcorder cannot play back an attached still image or moving picture if the file is in an incompatible format.

### To view an attached file

Exit the network function, then view the still image or moving picture following the same procedure as that for viewing a still image or moving picture recorded on a "Memory Stick." For details of saving attached files, see page 130.

### If no new messages have been sent to you

The message "No New Mail" appears.

### URL included in an email message

If a URL ("http://...") is typed in the message, tap it. The browser starts up automatically and accesses the indicated web page.

### Notes

- Up to 4,000 characters can be entered in an email message. If the number of characters exceeds 4,000, the excess characters are deleted and a message telling you so appears at the beginning of the text.
- The receiving procedure may take a while depending on the file size of the attached still image or moving picture.

### Tips

- You can have your camcorder check the email inbox automatically after sending email. For details, see "Setting other preferences" (p. 65).
- You can skip an email message if its file size is larger than specified. For details, see "Setting other preferences" (p. 65).
- The maximum number of characters for the subject and sender name of email is 24 each. You cannot read an email subject or sender name on your camcorder if it contains more than 24 characters.

 (New URL)	Enter the URL of a web page.
 (Page Memo)	Store the current page on the "Memory Stick." You can view the page later without accessing the Internet.
 (Page Information)	Show the title and URL of the current page.
 (Line Close)	The connection is disconnected.
	Hide the menu bar.
 (END)	Exit the browser.

## Viewing web pages

### When you fail to load a web page

The message [Loading Error] appears. Tap [OK], then tap  on the upper right of the LCD screen, and tap  in the menu bar. The Network Menu appears again.

The buttons may not function when viewing certain web pages.

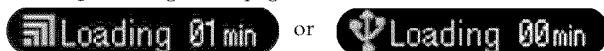
### Note on connection status indication

The connection status is indicated at the top of the screen. This item also shows the connected time and the address of the web page. The connected time indicated should only be used as a guide.

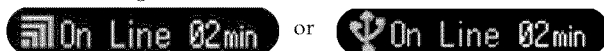

#### Notes

- If the address is too long to display, it is not indicated in full. If you want to know the entire address of the page, tap .
- A portion of the whole page appears on the screen.
- A large page takes more time to load, and its images or text may not be displayed properly. This is not a malfunction of your camcorder.
- When you try to load a large page, the message "Data too Large for Full Display" appears and the entire page may not be loaded.
- When viewing a scaled-down page, the screen may flicker or the colors may be strange. This is not a malfunction of your camcorder.
- To prevent a malfunction, operate the menu bar buttons after the entire page is loaded.

# Using as a Remote Camera

## - DCR-TRV80 only

You can operate your camcorder remotely from a BIP compatible computer or PDA with Bluetooth function.

You can use your camcorder as a remote camera and do the following:

- Recording the image with your camcorder while monitoring remotely with the screen of a connected device
- Zoom (telephoto/wide)
- Recording a still image on "Memory Stick"
- Tape recording
- Pan/Tilt  
(Using digital zoom function lets you perform Pan/Tilt even without a tripod, etc.)

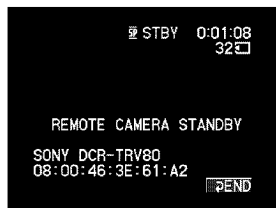
The functions you can operate are different depending on the connected Bluetooth device. For details, refer to the operating instructions of the connected Bluetooth device.

**You can use your camcorder as a remote camera up to three hours.  
Your camcorder automatically turns off after three hours.  
Do not use your camcorder for hours as a surveillance camera and such.  
Doing so may cause a malfunction.**

## Preparation

- (1) Set the POWER switch of your camcorder to CAMERA.
- (2) Tap FN and select PAGE3.
- (3) Tap RMT CAM.

The message "REMOTE CAMERA STANDBY" appears on the screen.  
When the connection is established, "REMOTE CAMERA" appears on the screen.



### Tips

- Certain Bluetooth devices require authentication to connect to your camcorder. When the passkey input screen appears on the screen of your camcorder, enter the passkey into the connected device.
- When the message "REMOTE CAMERA STANDBY" on the screen is displayed for five minutes and connection is still not established, the screen returns to PAGE3.
- The time limit for entering the passkey is 30 seconds. If it takes more than 30 seconds to finish entering the passkey, a passkey error occurs, authentication fails and your camcorder returns to connection standby.



# Using as a Remote Camera

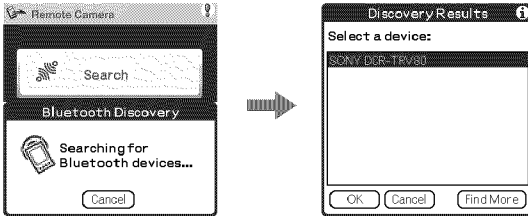
## Operating the Remote Camera

For details of operating the Remote Camera, refer to the operating instructions of the connected Bluetooth device.  
The following procedure shows you how to operate the Remote Camera function using a Sony PDA with Remote Camera Ver.1.1 installed.

- (4) Turn on the PDA.
- (5) Start up Remote Camera Ver.1.1 on the PDA.  
For details, refer to the operating instructions of the PDA.



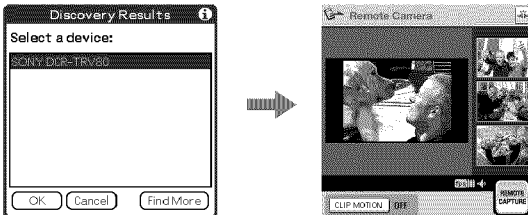
- (6) Tap "Search".  
The PDA starts searching for Bluetooth devices. When the search is complete, the available Bluetooth devices are listed.



### Tips

- To select from among previously connected devices, tap "Quick Search". A list of previously connected devices appears.
- If nothing appears in the list, tap "Find More" to start another search.

- (7) Select your camcorder name (e.g. DCR-TRV80), and tap "OK".  
The PDA goes into the Remote Camera mode.



For details, refer to the operating instructions of the connected Bluetooth device.

### Ending the Remote Camera

- (1) Tap **END** on the LCD screen of your camcorder to return to PAGE3.
- (2) Tap **EXIT** on the LCD screen of your camcorder to return to FN.

#### Notes

- When **START/STOP** or **PHOTO** is pressed, melody or shutter sound is output even if you set **BEEP** in **ETC** to **OFF** in the menu settings.
- Camera recording lamp lights up during recording even if you set **REC LAMP** in **ETC** to **OFF** in the menu settings.
- You cannot select **RMT CAM** during the following operations:
  - **MEMORY MIX**
  - Tape recording
  - Recording on “Memory Stick”
  - Using **USB Streaming** function
- If you set **Pan/Tilt** to **ON** in **RMTCAM SET** in **CG** in the menu settings, you cannot use the following:
  - **Digital zoom**
  - **SteadyShot** (The indicator flashes.)
- Remote Camera cannot be canceled during the following. After finishing recording, cancel Remote Camera.
  - Tape recording
  - Recording on the “Memory Stick”

#### Notes on Pan/Tilt

- The range in which **Pan/Tilt** can be performed varies depending on the zoom position. (Changing the zoom from **Wide** to **Tele** gives a wider **Pan/Tilt** range.)
- If **Pan/Tilt** is set to **ON** in **RMTCAM SET** in **CG** in the menu setting when you turn Remote Camera on or off, the zooming bar may appear in a different position. This is not a malfunction.
- The picture quality deteriorates slightly. If low picture quality is a problem, set **Pan/Tilt** to **OFF** in **RMTCAM SET** in **CG** in the menu settings on your camcorder, and then try to operate the connected device again.
- Set **Pan/Tilt** to **ON** in **RMTCAM SET** in **CG** in the menu settings before operating Remote Camera (The default setting is **ON**). To change the **Pan/Tilt** setting during remote operation of your camcorder, first quit Remote Camera and then change the setting in the menu.
- When you exit Remote Camera after altering the view angle with **Pan/Tilt** operation, the view angle returns to the center.
- If you set the zoom to **Tele** and change the view angle, and then set the zoom to **Wide**, the angle of view may return towards the center.
- The pan range with the zoom set to wide angle is narrower in **Wide** mode than usual.

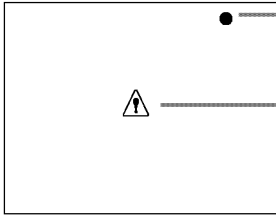

## Using as a Remote Camera

---

### Tips

- If you leave your camcorder on standby for more than five minutes:
  - While using Remote Camera, your camcorder does not turn off.
  - Standby is canceled.
  - Next time you record, it will take some time for recording to start.
- You can check the status of your camcorder from the connected device. You can select DSPL ON or DSPL OFF in CAM INFO in RMTCAM SET in  in the menu settings.



This appears during tape recording

This appears when an error occurs on your camcorder.

Examples:

- You tried to start tape recording without inserting a cassette.
- You tried to record a still image on “Memory Stick” without inserting a “Memory Stick.”

# Transferring still images with Bluetooth function – Image Transport

## – DCR-TRV80 only

You can transfer still images between your camcorder and Bluetooth devices that are compatible with BIP .

### Sending a still image

#### Before operation

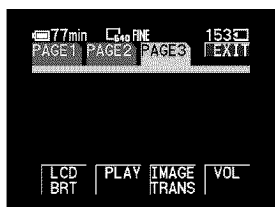
- Insert the “Memory Stick” that contains a still image you want to send to other Bluetooth device into your camcorder.
- Set a Bluetooth device to connection standby with your camcorder.

#### Tips

- You can send only JPEG files.
- The image may be resized or only sent as a thumbnail file, depending on the Bluetooth device connected.
- The protect and print mark settings become invalid in images received by the Bluetooth device.
- The file name and storage destination differ depending on the specifications of the connected device.

(1) Set the POWER switch of your camcorder to MEMORY/NETWORK.

(2) Tap FN and select PAGE3.



(3) Tap IMAGE TRANS.



(4) Tap PLAY.

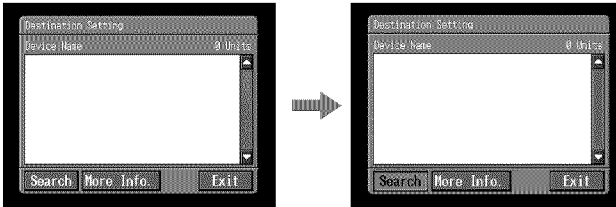

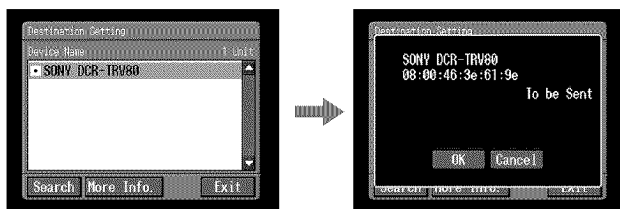

If your camcorder cannot search any Bluetooth devices available, the list does not appear. Check the devices, then tap [Search] again.  
If you want to cancel the search, tap [Cancel].

## Transferring still images with Bluetooth function - Image Transport

- (7) Tap the Bluetooth device that you want to send a still image to.



- (8) Tap [OK].  
Your camcorder starts sending the still image. If the Bluetooth authentication is required, tap [Passkey] and enter the passkey within 30 seconds.
- (9) Tap [OK].  
The screen in step 5 appears again.

### Viewing the history

- (1) Set the POWER switch of your camcorder to MEMORY/NETWORK.
- (2) Tap FN and select PAGE3.

If you leave your camcorder on standby for more than five minutes, the existing connection may be discontinued or a new connection may not be possible. In this case, connect your camcorder to the device again.

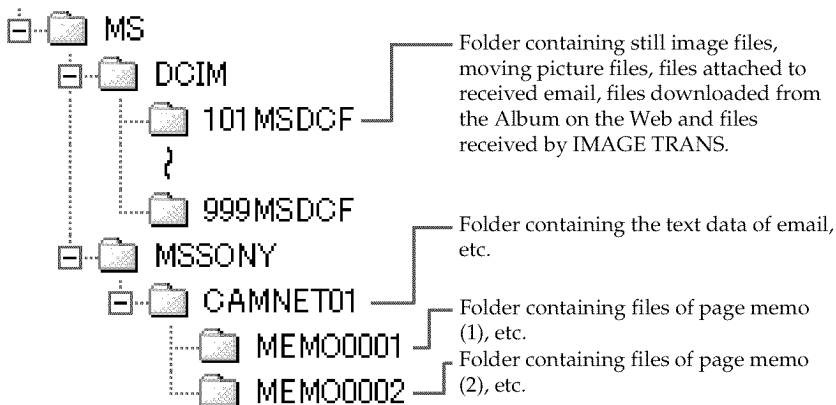

# Troubleshooting

## Trouble accessing the Internet

The message "...Incomplete" or "Authentication Error..." appears and your camcorder cannot access the Internet.

- **When setting network preferences with the "So-net" option**  
Check your setup by the procedure described in "Setting your provider preferences for "So-net"" (p. 38).
- **When setting network preferences with the "AOL" option**  
Check your setup by the procedure described in "Setting your provider preferences for "AOL"" (p. 48).
- **When setting network preferences with the custom setup**  
Check your setup by the procedure described in "Setting your provider preferences for other providers" (p. 54).

**Your camcorder cannot access the Internet.**

- Try accessing it again after a while.

The message "Line is Busy or Phone number may be Wrong" appears and your camcorder cannot access the Internet.

- The telephone line of your provider is busy. Try connecting again after a while.
- The settings for the telephone number may be incorrect. Check the settings.
- The telephone signal type settings (tone/pulse) of the USB-PSTN Modem Adaptor or the Modem Adaptor with Bluetooth Function may be wrong. Check the settings.

The message "Bluetooth Connection Error" appears and your camcorder cannot access the Internet.

- Check that the Bluetooth device is turned on.
- Move the Bluetooth device closer to your camcorder.

The message "Phone Line Disconnected" appears when making an entry in the online registration procedure.

- Data entry can be done offline. When your camcorder needs to connect with the site, the screen for verifying the connection appears. Tap [Connect], then the connection will be established again.

The message "Bluetooth Authentication Error Check the Certified Status" appears and your camcorder cannot access the Internet.

- The Bluetooth device may have been deleted from the registration. Register it again (p. 24).

The message "Bluetooth Connection Error Select Bluetooth Device" appears and your camcorder cannot access the Internet.

- Check your setup by the procedure described in "Registering Bluetooth devices" (p. 24).

The message "Low Battery" appears and your camcorder cannot access the Internet.

- Charge the battery pack or use the AC Adaptor, then connect again.

**You forget your ID and/or password.**

- Call Customer Support.

## Troubleshooting

### Trouble with email

The message "DNS Error The Requested URL Could Not Be Found" appears and your camcorder cannot send or receive email.

- **When setting network preferences with the custom setup**  
The DNS setup may be wrong. Check the PPP setting or LAN setting.

Your camcorder cannot send email.

- The clock of your camcorder is not set. Set the clock.
- **When setting network preferences with the "So-net" option**  
Check your setup by the procedure described in "Setting your provider preferences for "So-net"" (p. 38).
- **When setting network preferences with the "AOL" option**  
Check your setup by the procedure described in "Setting your provider preferences for "AOL"" (p. 48).
- **When setting network preferences with the custom setup**  
Check your setup by the procedure described in "Setting your provider preferences for other providers" (p. 54).
- Try sending the email after a while.
- If you use a LAN connection, you may not be able to use the email function, depending on your provider.

Your camcorder cannot receive email.

- The clock of your camcorder is not set. Set the clock.
- **When setting network preferences with the "So-net" option**  
Check your setup by the procedure described in "Setting your provider preferences for "So-net"" (p. 38).
- **When setting network preferences with the "AOL" option**  
As of March 2003, "AOL" does not support the receiving of email on this device. For further clarification on this and other "AOL"-specific attributes, go to keyword: Handycam on your computer.
- **When setting network preferences with the custom setup**  
Check your setup by the procedure described in "Setting your provider preferences for other providers" (p. 54).
- All of your downloaded email messages are stored on the "Memory Stick." Insert a new "Memory Stick" that has enough memory and download your email again. Also check that the lock switch is released.
- You can restrict the file size of downloaded email messages. Check the setup of the item "Restrict" on the Network Options screen.
- Up to 50 downloaded email messages can be stored on a "Memory Stick." If you want to store a 51st email message, delete unnecessary email or insert a new "Memory Stick" that has enough memory, then download the email again.
- If you use a LAN connection, you may not be able to use the email function, depending on your provider.

Not all of an email message can be received.

- The maximum size of an email is 4,000 characters. You cannot receive the entire text of email that has more than 4,000 characters.

The message "PPP Authentication Error" appears.

- **When setting network preferences with the "So-net" option**  
Check your setup by the procedure described in "Setting your provider preferences for "So-net"" (p. 38).
- **When setting network preferences with the "AOL" option**  
Check your setup by the procedure described in "Setting your provider preferences for "AOL"" (p. 48).
- **When setting network preferences with the custom setup**  
Check your setup by the procedure described in "Setting your provider preferences for other providers" (p. 54).

## Troubleshooting

### You received an email message sent from Mailer Daemon.

- Email you sent has not been delivered to the addressee. Check the email address. If you receive an email message from Mailer Daemon and the destination address is correct, the server may be down, or the email address may have been changed.

### Attached files are not saved on the "Memory Stick."

- Your camcorder can receive files with the following extensions: **.jpg**, **.mpg**, **.jpeg** and **.mpeg**. Check the file type.
- The message "Folder No. Full" appears when the "Memory Stick" is full. Delete any unnecessary data or insert another "Memory Stick," and then try to receive email again.
- All of your downloaded email messages are stored on the "Memory Stick." Insert a new "Memory Stick" that has enough memory and download the email again. Also check that the lock switch is released.
- You can restrict the file size of downloaded email messages. Check the item "Restrict" on the Network Options screen.

## Trouble viewing web pages

### Images do not appear.

- Check the item "Image Display" on the Network Options screen.

### Some or all of the web pages do not appear.

- A web page made with software such as Macromedia Flash may not be compatible with the browser of your camcorder.
- The web page with JavaScript and Java Applets cannot be executed with incompatible commands.

### It takes some time to load the web page.

- The web page may be busy. Try connecting through another provider or access point, or connect during off-peak times.

### The web page is not loaded.

#### → When entering its URL

Check that the address is correct. (For example, did you enter "0" or "O", "-" or "\_"?)

#### → When accessing through a bookmark or page memo

The address may have been changed or the link structure of the web site may have been modified. If the link structure is modified, follow the address to its source. (For example, when you cannot access "http://www.sony.co.jp/xxx/", then try to access "http://www.sony.co.jp/")

### The web page cannot be displayed.

- The item "Cookie" may not be checked. Check the item "Cookie" on the Network Options screen (p. 66).

### The cookie is not saved.

- Exit the network function, and the cookie will be deleted.

### The message "DNS Error The Requested URL Could Not Found" appears and the web page is not displayed.

- The item "DNS" may not be set correctly. Check the setup of the PPP screen or LAN screen.
- The item "Proxy" may not be set correctly. Check the setup of the Browser screen.

## Troubleshooting

### Troubles about the Album on the Web

The message "DI Customer ID profile incomplete" appears and your camcorder cannot access the Album on the Web.

- The DI customer ID is required to use the Album on the Web.


You cannot view or edit your album, send an invitation card, or upload still images and/or moving pictures. (A four-digit error code appears.)

- See "Album error codes" (p. 145).


It takes some time to load the album.

- The web page may be busy. Try connecting through another provider or access point, or connect during off-peak times.

A still image or moving picture cannot be deleted.

- There may be no still images and/or moving pictures. Tap .

A still image or moving picture cannot be downloaded.

- There may be no still images and/or moving pictures. Tap .

### Troubles about sending a still image

**- DCR-TRV80 only**

**SEND does not function.**

- A still image is not being played back.
- An invalid image is being played back.

The message "Bluetooth Authentication Error" appears, and you cannot send a still image.

- The authentication time limit (30 seconds) is over.
- You did not enter the correct passkey.
- The connected device was disconnected.
- The passkey you entered is wrong. Enter the correct passkey.

The message "Bluetooth Connection Error" appears, and you cannot send a still image.

- The Bluetooth device you want to connect to is not turned on.
- The Bluetooth device is too far from your camcorder.
- The radio waves between your camcorder and the connected device were blocked.
- The Bluetooth device you want to connect to is already connected to other devices.
- The connected device was disconnected.
- The Bluetooth device you want to connect to is not compatible with BIP.

The message "Bluetooth Communication Disconnected" or "Send Error" appears, and you cannot send a still image.

- The connected Bluetooth device is turned off.
- The Bluetooth device is too far from your camcorder.
- The radio waves between your camcorder and the connected device were blocked.
- The connected device was disconnected.
- The Bluetooth device you want to connect to is not compatible with BIP.
- The connection was rejected by the connected Bluetooth device. Check the settings or operations of the connected device.
- You sent the still image that the connected Bluetooth device cannot receive.

## Troubleshooting

### Troubles about receiving a still image

#### - DCR-TRV80 only

The message "Bluetooth Authentication Error" appears, and you cannot receive a still image.

- The authentication time limit (30 seconds) is over.
- You did not enter the correct passkey.
- The connected device disconnects or ends the connection.
- The passkey you entered is wrong. Enter the correct passkey.

The message "Bluetooth Communication Disconnected" or "Error Receiving" appears, and you cannot send a still image.

- The connected Bluetooth device is turned off.
- The Bluetooth device is too far from your camcorder.
- The radio waves between your camcorder and the connected device were blocked.
- The connected device disconnects or ends the connection.
- The "Memory Stick" does not have enough capacity.
- The sent still image is not a JPG or JPEG file.
- The sent still image is too large.

The message "Bluetooth connection Timeout" appears.

- If your camcorder does not receive any requests from the connected device for five minutes, the connection is disconnected or the camera becomes non-connectable. Connect your camcorder and the Bluetooth device again.

No request from the connected device.

- The device you want to connect with your camcorder is connected to other device. Disconnect the connection and connect the device with your camcorder.
- The time limit was exceeded. Set your camcorder to connection standby again.

The received still image cannot be played back.

- Your camcorder may not be able to play back incompatible JPEG files or files recorded by other devices properly.
- The still image is corrupted.

The index screen becomes blue.

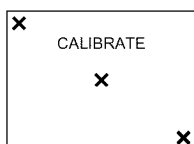
- The received files do not have thumbnails.

## Troubleshooting

### Adjusting the LCD screen (CALIBRATION)

If the buttons on the touch panel do not work correctly, follow the procedure below.

- (1) Set the POWER switch to OFF (CHG).
- (2) Eject the tape from your camcorder, then disconnect any connecting cable from your camcorder.
- (3) Set the POWER switch to VCR while pressing DISPLAY/BATTERY INFO on your camcorder, then keep pressing DISPLAY/BATTERY INFO on your camcorder for about five seconds.
- (4) Tap **X** displayed on the screen with the supplied stylus.  
The position of **X** changes.

#### Notes

- If you do not tap the right spot, you need to repeat step 4.

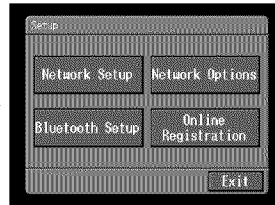

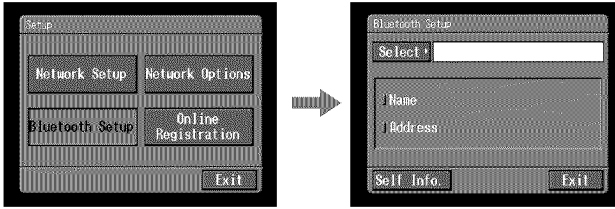



# Glossary

---

**Access point (p. 41, 58)**

A telephone number used to access the Internet, which is provided by an Internet service provider. Most providers install access points in various areas. We recommend that you select the most convenient access point with the lowest telephone charges.

**Address book (p. 93)**

Used to register email destination addresses.

**APOP (p. 59)**

An abbreviation for Authenticated Post Office Protocol. APOP is an authentication protocol for security. For details of whether your provider supports APOP or not, consult your provider.

**@ (At mark)**

Used to separate the domain name and the user name.

**Attachment (p. 90)**

To attach a file to an email message.

**BIP (p. 6)**

BIP stands for Basic Imaging Profile, the specification for the simple exchange of still images between Bluetooth devices, and remote camera operation from a Bluetooth device.

**Bluetooth**

Bluetooth technology enables reciprocal wireless communication between compatible devices via 2.4 GHz bandwidth radio, which is exempt from radio licensing requirements. It is for installation in small-sized and portable devices and provides high security and interconnectibility.

**Bookmarks (p. 110)**

Register your favorite or most frequently visited Internet web pages. Once you register a web page, you can visit it without entering its URL.

**Connect time (p. 109)**

The time connected to an Internet service provider with a dial-up connection. Most Internet service providers charge for the time connected.

**Cookie (p. 66)**

Used by the operator of an Internet site to identify the user. This is frequently used in online shopping.

**Device address (p. 137)**

The address of a Bluetooth device. Every address in the world is unique.

**Dial-up connection**

The dial-up connection is used to access the Internet through a telephone line.

**DNS (p. 45, 57, 63)**

An abbreviation for Domain Name System. This "DNS" is sometimes referred to as the "name server", "primary DNS server", "primary name server", etc. This is a server that replaces a domain name with an IP address. This is specified by an IP address.

**Download (p. 75)**

Load information from the server to your camcorder.

**Email (p. 82)**

Using a network, such as the Internet, you can send and receive messages very quickly. Email is easy to edit or store.

**Email address (p. 58)**

This is the destination address for email. There is no need to specify the country and the house number. Every address in the world is unique. You can receive email even if you are in another country.

**Forward (p. 103)**

To forward a received email message to another person. "Fw:" (Forward) is added to the beginning of the title to indicate that the email is a forwarded email.

**ID (p. 58)**

Used to identify the user in combination with a password when accessing the Internet through an Internet service provider.

**Internet (p. 36)**

A worldwide network of computers. You can use email, information retrieval services, etc., over this network.

**Internet service provider (p. 36)**

Sometimes referred to as the "Provider", "ISP", etc. It is a company that provides access to the Internet.

**LAN**

An abbreviation for Local Area Network. A LAN is a network of computers within a limited area connected by a comparatively high speed data transmission method, such as Ethernet.

**Link**

A related page address shown on another web page as a web link.

**Login (p. 68)**

Connect to a specific service by entering an ID and password.

**Passkey (p. 24)**

The passkey is an identification number needed to allow two Bluetooth devices to communicate with each other. This "Passkey" is sometimes referred to as the "Bluetooth passkey", "PIN", "Bluetooth PIN", etc.

**Password**

Used to access the provider in combination with a user ID.

**POP3 (p. 58)**

An abbreviation for Post Office Protocol, Version 3. It is a server used to receive email.

**PPP (p. 57)**

An abbreviation for Point to Point Protocol, Version 3. It is a protocol for accessing a provider with a dial-up connection.

**Proxy (p. 59)**

A server or program to allow a computer located inside a firewall pass through the firewall.

**Reply (p. 102)**

To reply to a previously received email message. When replying, "Re:" (Reply) is added to the beginning of the title to indicate that the email is a reply.

**Security**

Computer security means the overall preservation of safety of a computer system. It includes the protection of data against vandalism and accidents, and the prevention of illegal use of data.

**Signature (p. 92)**

Used to add your name, address, etc., to the end of a message.

**SMTP (p. 59)**

An abbreviation for Simple Mail Transfer Protocol. It is a server used to send email.

**SSL**

An abbreviation for Secure Sockets Layer. It is a protocol for exchanging information safely between web browsers and web servers. SSL is frequently used for credit card transactions over the Internet. SSL also has ownership verification and to data encryption functions.

**Subject (p. 85)**

The title of an email message. When replying, "Re:" (Reply) is added to the beginning of the title to indicate that the email is a reply. When forwarding an email message, "Fw:" (Forward) is added to the beginning of the title to indicate that the email is a forwarded email message.

**Upload (p. 68)**

Load data such as still images and moving pictures from your camcorder to the server through the telephone line.

**URL (p. 106)**

An abbreviation for Uniform Resource Locator. It is an address on the Internet. By specifying this address, you can access the web page.

**Web page (p. 106)**

A web site that makes information available on the Internet. When the page includes web links, you can select them to specify other pages.

**Web page address (p. 106)**

The address of a web page on the Internet. See also "URL".

**Wireless communication**

Radio communication. Devices can be connected without using cables.

### Your Privacy

At Sony we believe our online visitors have a right to know our practices regarding the information we may collect when you visit our Web sites and what type of information is collected. The guidelines contained herein apply only to your visit to the Web sites operated by or for Sony Electronics Inc. and the entities it controls (collectively, "SEL"). These sites include, but are not limited to, those that contain "sel.sony.com" and those that contain "sonystyle.com" in their URLs. ### **1. Terms**
